
POWER DISSIPATION:Pd(%)




CLAMPING VOLTAGE:VcI(V)



CLAMPING VOLTAGE:Vcl(V)





TRANSIENT THAERMAL IMPEDANCE: $R_{th}({}^{\circ}C/W)$





