








# **Typical Electro-Optical Characteristics Curves**











# **Package Dimension & Internal Circuit Diagram**











#### **Reel Dimensions**






#### **Packing Process**

## **Preheat**

Temperature min (T <sub>smin</sub> )	150 °C
Temperature max (T <sub>smax</sub> )	200 °C

Time  $(T_{smin} \text{ to } T_{smax})$   $(t_s)$  60-120 seconds Average ramp-up rate  $(T_{smax} \text{ to } T_p)$  3 °C/second max.


